2017 Pinecliff Trash Service by Hollis Shumway

A new year is upon us and it's time to renew your Pinecliff Trash Service! We are entering into our 5th very successful year of our partnership with Bestway Disposal with 425 residents participating. As a benefit of being a member of the Pinecliff Homeowner's Association, you receive reduced trash pick up rates. It also benefits the neighborhood with reduced trash truck traffic – less noise, less wear & tear on the streets. A win-win!!

We welcome all Pinecliff Homeowner's Association members to take advantage of this great service! If you want to join our trash service, complete the Trash Service Agreement found on our website, www.Pinecliff-hoa.com (Trash Service) and make payment prior to service being started. Additional details are also included on our website. Existing customers just need to make payment for the upcoming year! Just a reminder, all Trash Service participants must be current members of the Pinecliff Homeowner's Association.

Renewals start now and must be completed by February 17, 2017 to avoid any unnecessary interruption in service. Payments can be made one of 4 ways:

Be sure to make checks payable to "Pinecliff Homeowner's Association".

We are pleased that trash and recycle rates have remained the same for the upcoming year!! Carryout fees have increased; however the new rates for carryout will remain the same for three years!

- * Trash & recycling charges for the upcoming year, 3/1/17 2/28/18, \$11 for trash per month and an additional \$5 per month for recycling.
- * Carryout driveways 150' or less \$3 to \$5 per month.

Carryout Long - driveways greater than 150' - \$6 to \$10 per month.

Carryout Extra Long - Extra long driveways determined by Bestway - \$9 to \$20 per month.

Trash Service rates for the **year** beginning 3/1/17 is as follows:

- * Trash Only (T) = \$132
- * Trash & Recycling (TR) = \$192
- * Trash Only, Carryout (TC) = \$192
- * Trash & Recycling, Carryout (TRC) = \$252
- * Trash Only Carryout L (TCL) = \$252
- * Trash & Recycling, Carryout L (TRCL) = \$312
- * Trash Only, Carryout XL (TCXL) = \$372
- * Trash & Recycling, Carryout XL (TRCXL)=\$432

Popes Valley Four Way Stop Signs by Carl Peterson

This past summer some residents on Popes Valley contacted our City Council Representative Don Knight and the City Traffic Engineering Division about perceived speeding on Popes Valley Drive. Your board became involved in the process shortly thereafter. In order to provide hard data of a speeding issue, the city Traffic Engineering Division conducted a traffic study at three locations on Popes Valley Drive for 24 hours on Tuesday, 27 September 2016. The three locations were as follows: (1) 395 Popes Valley Drive; (2) Popes Valley/Setters Way intersection; and (3) 870 Popes Valley Drive. The devices used to record the traffic looked like large hockey pucks nailed in the asphalt at the three locations listed above. Traffic times, speeds, volume, and roadway temperature were recorded and are summarized on the following page.

Based on the data collected, the city deemed it appropriate to institute a traffic calming procedure. Traffic calming procedures such as speed bumps, pavement scoring, radar speed display signs, additional speed limit signs, children at play signs, city sponsored speed patrols, city post cards to the neighborhood identifying the speeding problem, and additional stop signs were discussed at two meetings with the city in October and November. Don Knight attended the first meeting.

The city does not advocate using speed bumps due to the negative impact on emergency vehicles, snow plows, and associated noise when vehicles go over them. Pavement scoring was not viewed by the city as a positive solution. City traffic representatives stated radar speed limit signs only work for three months. The city stated they would install an additional 25 MPH speed limit sign advising west bound traffic of the change in allowed speed from 30 MPH when entering Pinecliff from Rusina to the Pinecliff entry sign so that drivers are more aware of the need to slow down in the populated area of Pinecliff. Also, the city mailed a postcard advising Pinecliff residents of the speeding problem on Popes Valley Drive. Children at Play signs will not be installed by the city.

Finally, the city representatives determined that additional stop signs at the intersection of Popes Valley Drive and Golden Hills Road with crosswalks would be appropriate, making the intersection a four way stop to slow drivers based on data collected from the 27 September traffic study. Also, the proximity to Pinecliff Park was a contributing factor to the four way stop location. Finally, there are red flashing lights above the new stop signs for six months to alert drivers.

Pinecliff Road Repair Conditions by Carl Peterson

Your board has submitted over 14 pages of potholes to be repaired in Pinecliff to the city this past year in 2016. The city response time to repair the potholes has varied from a week to several weeks. Recently, the response time has decreased significantly. Unfortunately, the cold weather and snow work in concert to have a deleterious effect on pothole repairs. The cold weather forces the city to use a "cold asphalt mix" versus a "hot asphalt mix." The cold mix doesn't last as long as the hot mix. Most recently, in November, your board called in 77 potholes to be repaired on Point of the Pines going downhill to Elkton Drive. The city has repaired most of them, but still has many to fill. Your board will keep on it.

As a result of the 2C road repair funding initiative passed in November of 2015, funding of the Point of the Pines repaving was transferred from PPRTA to 2C. With 2C funding, the city agencies began to coordinate their infrastructure repair efforts. There have been two water main leaks in the 700 block of Point of the Pines in the last two years that your board is aware of. In previous years to that, there have been additional water main leaks. As a result, Colorado Springs Utilities will conduct water main repairs before the city streets division repaves Point of the Pines. That delays Point of the Pines repaving to the 2018 timeframe.

Your board is aware that some Pinecliff residents report potholes to the city. Your assistance is welcome! If you are driving in Pinecliff and you see a pothole or other needed road repair conditions, you can help yourself, your neighbors, and your board when you:

Police Events in Pinecliff During 2016 by Carl Peterson

There were 153 police responses to activities in Pinecliff last year in 2016, which averages out to just over 12 ½ per month. The 153 events of 2016 were categorized as follows (the number behind each category is the number of that kind of category): Disorder – 44, Noise – 5, Other – 11, Proactive Policing – 4, Property – 59, Traffic – 15, Violent – 15. Clearly the two largest categories were Property with 59 events, and Disorder with 44 events. So we will break those two categories down as follows, for Property events: Alarm – 41, Burglary 6, Burglary-Auto – 2, Criminal Mischief – 2, Theft – 6, and Trespassing - 2. That totals 59 Property related events that resulted in the filing of a police report. For the Disorder category, the events are as follows: Disturbance – 14, Fraud – 6, Ordinance Violation – 1, Suspicious Circumstances - 5, Suspicious Vehicle – 6, suspicious Person – 5, Sex Registrant Violation – 6, and Shots Fired - 1. These Disorder events total 44. Also, as noted above, 41 of the 153 police responses were to alarms, which comprised 27% of the police responses. 

This will be a new, two story, 28,000 sq. ft. building that will be located near the corner of Elkton Road and Chestnut Street and be directly below a number of homes in Sunbird Cliffs. The facility will house training and class rooms, 2 swimming pools, and administrative offices. Pikes Peak Athletics is a well known and highly regarded competitive swim coaching business. "The Development Plan and Final Plat have completed their process and all notes/plan alterations that were discussed at the hearings were made prior to stamping. I believe their goal is to start construction in the spring/summer, but you may want to confirm that with George Heidinger."
